Ambitious Targets

Take action to achieve the following ambitious GHG reduction targets in order to restrict warming to less than 1.5°C:

Near term

- At least 25% reduction of our Scope 1 & 2 emissions within 5 years.
- At least 15% reduction of our Scope 3 emissions within 5 years (excluding food & beverage supply chain emissions).
- At least 31% emissions reduction per diner within 5 years and a base year cap on absolute food & beverage Scope 3 emissions.

Long term

- At least 90% reduction across all of our emissions, including Scope 3, by 2050 (excluding food & beverage supply chain emissions).
- At least 70% emissions reduction per diner by 2050 and a base year cap on absolute food & beverage Scope 3 emissions.
